Background.

It is a legal requirement that a Goods Vehicle Operator employ a professionally competent person to manage their transport operation, if they intend to provide 'Hire or Reward' services.

The professionally competent person will be appropriately qualified, and will be required to demonstrate that they are in **continuous and effective control** of the transport operation to which they have been nominated, and serving as a TRANSPORT MANAGER.

Qualification.

OCR are the leading awarding body for Level 3 Certificate of Professional Competence (CPC), a vocational qualification. The qualification is designed for individuals who aspire to work as a Qualified Transport Manager for an existing or proposed Operator, including those who wish to take up the challenge of becoming an Operator themselves. BEING QUALIFIED PROVIDES YOU WITH A LICENCE TO PRACTICE.

There are no minimum qualification (academic or vocational) to be entered for examination, and all CPC examinations are designed to meet appropriate accessibility requirements.

Examinations.

In order to become qualified, candidates must pass two separate examinations.

**Multiple
– Choice**

R1(05680) The examination is a 120 minute multiple choice **e-Test** of 60 questions. 70% (42/60) is required for a pass. This is an 'on-screen' alternative to the paper-based variant. Results are available within minutes of the test being completed. Appointments for this Examination can be made with Transportwise to suit your convenience.

**CASE-
STUDY**

R2 (05689) The examination is a 135 minute Case-study paper. 50% (30/60) is the notional pass mark. **This is an open-book examination. This means that candidates are permitted to have 'hand-written' study material with them during the examination.** Results are notified to your Centre approximately seven weeks after the Examination. The R2 Examination is available four times each year.
